Broker Solutions Guaranteed Hire Vehicle Insurance is intended to provide cover for a hire vehicle to be provided by an approved hire vehicle provider whilst your vehicle is rendered undriveable due to an insured event, or where we cannot provide a hire vehicle, we will reimburse your transportation costs.



#### What is Insured?

#### What is not Insured?

Use of the hire vehicle outside of Great Britain.

What are my obligations?

- Any insured vehicle used in any way for hire or reward including courier work, unless authorised by Chief Vehicle Rentals.
- Any excess that the hire company applies following an accident, fire or theft involving the hire vehicle.
- Any claim where you did not hold a valid licence at the time of the insured event.

#### Are there any restrictions on cover?

- ! A maximum of 2 claims can be covered under this insurance policy in any one period of insurance.
- ! Any claim must be notified within 14 days of the insured event and during the policy period.
- ! The maximum number of days we will provide cover for the arrangement of a hire vehicle as shown within the schedule.
- In the event that a hire vehicle cannot be provided, the maximum amount we will pay for transportation costs shall be £20.00 plus VAT per day, up to the maximum number of days cover shown within the schedule.
